Methods and materials for containment and cleaning up : Use dust explosion-proof type electric equipment and lighting. Electrically conductive containers must be grounded. Do not use compressed air for cleaning purposes. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Pick up and arrange disposal without creating dust. Sweep up and shovel. Keep in suitable, closed containers for disposal.

SECTION 7. HANDLING AND STORAGE

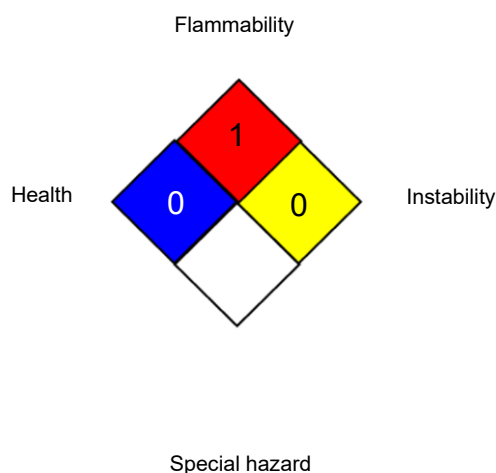
