A 13-week inhalation study in rats of a compositionally similar acrylic powder showed inflammatory effects in the lung at concentrations of 6 mg/m³ for 6 hours per day, 5 days per week. These findings were consistent with high concentration exposure effects reported for other non-soluble dusts.

Maintaining airborne dust concentrations within the recommended exposure limit is not expected to produce adverse effects within the lung.
