SECTION 7. HANDLING AND STORAGE

- Advice on protection against fire and explosion : Do not spray on a naked flame or any incandescent material. 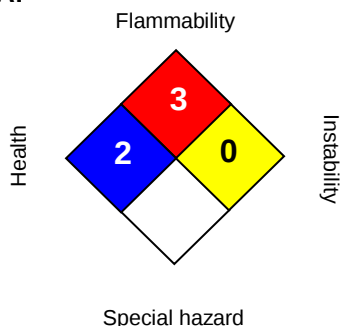
